Did you know that registering for Pupil Premium means that your child's school gets extra money?

Pupil Premium Funding

Pupil Premium is additional funding for publicly funded schools in England to raise the attainment of disadvantaged pupils or pupils from low income families, to help support eligible pupils to reach their potential, both academically and socially.

Pupil Premium gives schools extra funding to raise the attainment of disadvantaged pupils from Reception to year 11.

The government introduced the fund in April 2011 to give schools funding for children who:

- were registered as eligible for Free School Meals
- had been Looked After for 6 months or longer

Schools can decide how the Pupil Premium is spent, since they are best placed to assess what additional provision should be made for the individual pupils within their responsibility.

At Pimperne Primary School we support all of our pupils. We do this by providing high quality classroom teaching which is supplemented by interventions to support vulnerable learners as and when required. The School Leadership Team and Governing Body monitor the impact of all spending and interventions including the Pupil Premium.

How do you apply for Pupil Premium Funding?

If you think you may be able to support your child's school further by completing the application due to low income or because your child is a Looked After or Cared for Child – **please do!** Every bit of additional funding the school receives plays a huge part in maintaining our belief in supporting every single child in our school.

Pupil Premium Funding – most people who are in receipt of one of these are eligible for Pupil Premium Funding:

- Income Support
- income-based Jobseeker's Allowance
- income-related Employment and Support Allowance
- support under Part VI of the Immigration and Asylum Act 1999
- the guaranteed element of Pension Credit

- Child Tax Credit. This is as long as you are not entitled to Working Tax Credit and your annual gross income isn't more than £16,190
- Working Tax Credit 'run-on' payment (paid for four weeks after you stop qualifying for Working Tax Credit)
- Universal Credit

My child has just started school and already has brothers and sisters who get free school meals - do I need to reapply?

Yes - you need to re-apply so that the new child can be included in the family's current free school meals award.

My children qualify for free school meals, but the school will know about my financial situation if I apply. Can I apply without the school knowing how much I receive in benefits?

The arrangements for checking benefit evidence do not disclose how much you receive, or even which benefit you receive. Therefore, the school will not be able to see this information.
